We noticed that our property (the grass area) had multiple vehicles parked on it from citizens attending the ballgame at the ballpark. Committee members recalled that at one time there was a low fence made of wooden posts with a length of equally hearty lumber between them the length of the driveway shared with our neighbor, PAC group. Protecting the grass with this fence barrier would deter access to the lawn for vehicles and eliminate the need for the old chain link fence separating the two areas. (and look better too).
